Tajikistan, KP agree to increase bilateral trade volume

PESHAWAR: The Ambassador of Tajikistan Ismatullah Nasruddin and the delegation visited office of the KPK Board of Investment to call on Special Assistant to Chief Minister on industries Abdul Karim Khan, Vice Chairman KPBOIT Mr. Said Mahmood and CEO KPBOIT Dr Hassan Daud Butt. Vice Chairman welcomed the delegation and in his introductory remarks gave an over view about Khyber Pakhtunkhwa and potentials of bilateral trade with Tajikistan. Dr Hassan Daud Butt, CEO, Khyber Pakhtunkhwa Board of Investment, gave a detailed presentation on investment opportunities in Khyber Pakhtunkhwa in key sectors including tourism, IT, SEZs, Agriculture and Livestock, Mines & Minerals, IT and Hydel Power. During the briefing he also highlighted top exports and imports of Pakistan with Tajikistan and emphasized on the need to enhance the bilateral trade. Special Assistant to chief minister for industry and trade welcomed the Ambassador of Tajikistan and assured full cooperation from the provincial government in promoting bilateral trade activities and in the province's vast minerals, hydropower and tourism sectors. Elaborating investment opportunities, he said that Khyber Pakhtunkhwa has a vast untouched natural potential that need to be explored. Ambassador thanked for the warm welcome, and in his remarks he emphasized the importance of boosting bilateral trade ties, and highlighted the recent efforts to boost trade activities between the two countries and said that launching of air services for commercial purposes is need of the day as the two countries share common values. The ambassador invited a business delegation from Khyber Pakhtunkhwa to visit Tajikistan and to hold an exhibition of Pakistani local products in Dushanbe and ensured all the support for the visit. He also mentioned that meeting of the delegation with Tajikistan Government officials will also be arranged during the visit. The ambassador also emphasized that 4 to 5 areas of mutual cooperation must be identified before the visit to work on. At the end of the briefing, CEO KPBOIT proposed few recommendations including forming of a working group to enhance trade
